The offer of appointment (Memorandum) to the candidate(s) will be issued by CGST Ahmedabad South Commissionerate by specifically mentioning the Commissionerate, where the candidate has to report for joining. Further, CGST Ahmedabad South Commissionerate shall hand over the dossiers of candidates to the respective Commissionerates along with a copy of the offer of appointment for further necessary action.

The procedure for dispatch of offer of appointment to the candidate and return of dossiers of candidates who decline to accept the offer are specifically mentioned in para-7 of Board's aforesaid letter dated 15.09.2021, which may be followed scrupulously. The joining status report in respect of newly appointed candidates may be sent to the Board on or before **12.01.2022** positively, under intimation to this office.
- 5. Copy of the Memorandum issued should also be endorsed to the Cadre Control Unit, O/o The Chief Commissioner, CGST Vadodara Zone. The CGST Ahmedabad South may issue the offer of appointment on or before

- **22.12.2021**. The concerned Commissionerate may collect the dossier of the candidates from CGST Ahmedabad South on or before **24.12.2021**.
- 6. The Seniority of the candidates will be fixed as per existing orders on the subject.
- 7. In case, any discrepancies found regarding Name, Date of Birth, Rank, Category etc., the details given in the dossier of Individual may be treated as final.
- 8. All representations received regarding allocation of Commissionerates stands disposed off. No further representations in the said matter will be entertained.
